- 2) The proposed Tenderers shall read and understand the terms and conditions mentioned in the Tender Sale Notice which is published by the Company at its Regional Offices/Head Office/Mazhuvannur branch and other branches and also visit the scheduled properties and satisfy as to its area, boundaries etc., ownership, title, encumbrances, statutory approvals, measurements etc. The Company shall not entertain any dispute regarding the Tender Process or the scheduled property after participating in the sale.
- 3) Interested Tenderers shall produce a copy of any valid photo identity/address proof, in case, the tenderer is participating on authorization, he should produce the ID proof of himself and the Tenderer.
